3. Buildings with a required plumbing fixture count less than 12
4. Work completed by a government subdivision or state agency costing less than \$15,000.00.

Plans are required for all other building types and shall be prepared by or under the direct supervision of an architect or engineer licensed pursuant to 1980 PA29 and shall bear the architect's or engineer's seal and signature. ☐ Plans Not Required

## V. APPLICANT SIGNATURE

## VII. FEE CLARIFICATIONS

**ITEM #2, MOBILE HOME UNIT:** When item issued for sewer excavations in new park, the permit application should indicate the application fee plus the number of unit sites. When setting a mobile home in a park or a mobile or modular home on private property, a permit should indicate the application fee, a sewer or building drain, a water service or distribution pipe.

## IX. INSTRUCTION FOR COMPLETING APPLICATIONS

**GENERAL:** Plumbing work shall not be started until the permit has been issued or other approval has been obtained. All installations shall be in conformance with the State of Michigan Plumbing Code. No work shall be concealed until it has been inspected. When ready for an inspection, call the inspector providing as much advance notice as possible. The Inspector will need the Job Location & Permit Number.

**EXPIRATION OF PERMIT:** A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. A permit will be cancelled when no inspections are requested and conducted within six months of the date of issuance or the date of a previous inspection. Cancelled permits cannot be refunded or reinstated.

**WHERE TO SUBMIT APPLICATION:** Permit applications for Township issued permits should be sent to the address listed on the front of this application. If you are not sure whether a Township permit is appropriate, contact your local inspector.
